Message from the Associate Alumnae of Douglass College

President Jeanne M. Fox '75, Esq.

After many months of mediation and negotiations and on behalf of the Associate Alumnae of Douglass College Board of Directors, we announced on July 20, 2016, that a binding agreement titled, "Agreement Among Rutgers University, Rutgers University Foundation, Associate Alumnae of Douglass College and The Douglass Fund" was reached to end the dispute among AADC and the Rutgers parties regarding the AADC's status within the University. Many of you have received digital announcements from AADC leaders about various issues and the AADC's status. In addition, the signed Agreement was promptly published on our website on the "Latest Updates" page for alumnae to gain a better understanding of its terms.

Our alumnae-led team, which spent many hours in mediation sessions and arduous negotiations, can assure alumnae that the AADC came to this Agreement in good faith to mutually resolve outstanding issues. Compromises were made by all parties involved.

As background, you are probably aware that on April 20, 2015, Rutgers informed the AADC that it was changing the status of our alumnae organization to be consistent with the status of other chartered organizations within the Rutgers University Alumni Association (RUAA). This directive would have prohibited the AADC from employing paid staff, conducting student programs or raising money for the AADC, Douglass or her students. The AADC's historic role as the primary fundraiser for Douglass had been designated in a signed 2005 agreement

with the University. That agreement was terminated unilaterally by the University, Rutgers University Foundation and DRC in April, 2015. The parties agreed to mediate these and other issues. Mediation began in July, 2015, and ended last fall, when all parties agreed to continue negotiating a settlement that culminated in the Agreement signed on July 20, 2016.

The Mediation/Negotiation team consisted of our outside legal counsel, myself and AADC

Board members Jennifer C. Bender '93, Helen Jordan Galt '69 and former Board member M. Wilma Harris '66. These women have extensive professional experience as well as service in leadership roles within the AADC and the University. AADC Executive Director Valerie Anderson '81 was added to the team when negotiations began. And our PR Team has been led by Board member Tina Gordon '72. We commend these dedicated volunteers and alumnae who have shown tremendous advocacy

and devotion to the success of this amazing organization.

To share the news, we hosted a series of AADC Town Hall Meetings, including a well-attended online live presentation via our Douglass Alumnae Facebook page. The briefings with alumnae and groups, including donors, class officers and regional groups, explained the Agreement and provided an opportunity to ask questions. Please see page two for some of the key terms of the Agreement. In addition, a special mailbox has been set up to which you can direct questions. The AADC, proudly formed in 1922 and incorporated in 1927, will continue to operate as an independent and self-supporting 501(c)(3) charitable organization to fulfill our mission. Let me reassure you that any donations you make to the AADC are retained by the AADC and used either as the donor has requested or to support our mission. For your information, unrestricted gifts to the AADC Annual Appeal are used to seize unique opportunities which empower and strengthen our sisterhood, to direct funding to alumnae initiatives that are of the greatest priority and to support general administration, which allows us to be a best-in-class alumnae organization.

Thank you to everyone for your support, e-mails, letters, phone calls and donations. We want to assure you that the AADC remains strong and vital. We appreciate the concessions made by both sides to reach a workable agreement. We welcome this

opportunity to expand our AADC programs and services to alumnae so that we can maintain and strengthen our dedicated sisterhood. Our Board of Directors is committed to developing key initiatives to help our community – a network that is more than 37,000 alumnae strong – remain connected. As alumnae we look forward to the 95th Anniversary of the

alumnae association's founding, in June of 2017, by sharpening our focus and creating dynamic new initiatives to serve and connect alumnae. Our vision includes capitalizing on technology to allow virtual connections with alumnae in the various regions of the country; offering unique educational experiences that allow alumnae to benefit from the rich expertise

within our sisterhood that encourages lifelong learning; and building the organizational experience needed to respond to the ever-changing needs of alumnae. We encourage you to stay connected with each other through the AADC. Please support the AADC with your generous gifts to ensure a bright future. This is YOUR alumnae organization.

## The parties have agreed on the following points:

- Under the terms of the Agreement, the AADC remains an independent, self-funded organization serving the alumnae of the New Jersey College for Women (NJC), Douglass and Douglass Residential College (DRC). The AADC continues as a chartered organization within the Rutgers University Alumni Association with all rights and privileges. There are certain exceptions allowed, such as the AADC's being permitted to raise money to fund our alumnae programs and AADC operations, employing paid staff and raising money for Fellowships for post-graduate studies for Douglass alumnae.
- The AADC retains the rights to use the name "Associate Alumnae of Douglass College," along with the pine tree in its current logo, in perpetuity.
- The AADC retains full fiduciary responsibility for the management of the Douglass Fund, the endowment established by the AADC in 1969 exclusively for the benefit of Douglass and her students. The AADC will appoint individuals from the AADC Board to serve as Trustees of the Fund, which the AADC will continue to steward. It shall be controlled by the Trustees who shall hold the following positions at the Association: The President of the AADC; the Executive Director of the AADC; and a person appointed by the AADC President and confirmed by the Board of Directors. The restricted money in the endowment will be used according to each individual donor's intent as it always has been.
- The AADC mission remains the same in its support of the College through our responsibility for the Douglass Fund. The AADC will refocus its programs to provide new and enhanced experiences and services for alumnae, expand our networks and strive to remain a best-in-class alumnae organization.
- The AADC will not conduct programs specifically for DRC students. If one of our programs or events is relevant to students, the AADC can ask the DRC Dean whether students may be invited. There may be joint programs if the Dean and the AADC agree a program is in the best interest of the College, its students and the AADC.
- The AADC will continue to fund alumnae programming and its own operations through the Associate Alumnae of Douglass College Annual Appeal and through approved fundraising for certain events, programs and activities, including those organized for regional groups and affinity networks. The AADC will be able to solicit and accept bequests and gifts that benefit the AADC. Donations continue to be tax deductible. The AADC will follow Rutgers' policies and industry practices on fundraising, which include the common practice of taking a gift assessment on donations to help in the costs of fundraising. This fee stays with the AADC.
- The AADC will continue to operate out of the Ruth Schilling Hennessy Alumnae Center, our home on the Douglass campus. We will pay a usage fee to Rutgers and share space in the building with tenants from DRC.

## Joyce Kovatch Albers-Schonberg '65

Scientist, Highly-Recognized Investment Analyst & Philanthropist

Throughout her career in the pharmaceutical industry and investment management industry, Joyce Albers-Schonberg has focused on health care innovation through her work in biochemistry research and in the investment world of Wall Street, identifying promising new investments in health care.

Joyce joined the Merck Research Labs as a Biochemist after graduation from Douglass in 1965. After a 13-year career at Merck working on new anti-viral and anti-tumor agents and anti-hypertensive drugs, Joyce decided to combine her love of science with an interest in the business aspects of health products. She took a leave from her job to pursue an MBA in Finance and Marketing at New York University School of Business, graduated with honors and was inducted into Beta Gamma Sigma, the national scholastic honor society for business.

With her new degree, Joyce joined the investment bank First Boston in 1980 as an equity analyst covering the health care services industry where she became nationally recognized for her investment expertise and for many years was ranked as the number one analyst in the industry by *Institutional Investor Magazine*. Joyce was also highly commended by Institutional Investors for her research and investment recommendations in the Pharmaceutical Industry. She was a guest on "Wall Street Week" with Louis Rukeyser, "CNN Business News" and was frequently quoted in the *The Wall Street Journal* and *The New York Times*. In 1995 Joyce became a partner in a start-up hedge fund, Deerfield Management, which specialized in investing in health care companies. The Fund grew from \$100 million to \$700 million over the five years that she was an active partner.

After she retired in 2000, Joyce spent more time focusing on philanthropy and community service. Her service at the AADC has been significant and impactful. Joyce has served as Chair of the Investment and continues to serve as member of that Committee. She served as Class President from 1980-1984. She has served as class fund agent, raising over \$54,000 in 2000 to create the Class of '65 Scholarship Fund. She has been a member of the Board of Directors and most recently served as Co-Chair of the highly successful Campaign for Douglass.

Joyce and her husband, Georg, have funded two scholarships. Joyce's philanthropy provided the funds needed to create the Women in Entrepreneurial Business House Living Learning Community and she continues to support the activities of students garnering business experience in this community. She was a significant donor to the new Kathleen W. Ludwig Global Village Living Learning Center. In recognition of her generosity and

leadership, the assembly hall in the new building is named the Joyce Kovatch Albers-Schonberg '65 Assembly Room.

She established a family foundation that has funded a new home for a low income family in Trenton through the Martin House and a Stroke Program at the University Medical Center at Princeton. She has served on the Rutgers Board of Overseers since 2005, and been a Trustee for the Princeton Healthcare System Foundation and George Street Playhouse. Joyce has been awarded the Douglass Alumnae Recognition Award, the Corwin Award, the Rutgers Scarlet Oak Meritorious Service Award and the 2012 New Jersey Women of Achievement Award from the New Jersey State Federation of Women's Clubs of GFWC. As a student at Douglass, Joyce majored in microbiology and minored in chemistry. She also was selected to be a House Chairman and an assistant lab instructor in Microbiology.

## Sharon Perlman Krefetz '67

Distinguished Educator and Community Leader

Sharon Perlman Krefetz has had a distinguished career in Higher Education and has been a devoted leader of several community organizations. After her graduation from Douglass, she earned M.A. and Ph.D. degrees in Politics from Brandeis University and began teaching in the Political Science department at Clark University in 1972. In the mid-1970s, she co-founded the Women's Studies Program at Clark and later served as its Director. During her more than four decades as a member of the Clark faculty, Sharon received a number of awards for outstanding teaching, including being named one of the top 125 Outstanding College and University Teachers by the American Association for Higher Education.

In 1992, Sharon was appointed Dean of the College at Clark, a position she held for eight years. She also served as Associate Provost of the University from 1994-2000. In these positions she led the planning and implementation of a number of new academic initiatives, including the establishment of a Center for Excellence in Teaching and Learning and the creation of several new interdisciplinary academic programs.

After completing her second term as Dean and Associate Provost, and before returning to teaching, Sharon spent a sabbatical year as a Fellow at the Joint Center for Housing Studies at Harvard University and as a Visiting Scholar at Brown University's Taubman Center for Public Policy and American Political Institutions. She has also been a Visiting Scholar in the Public Policy Department at Tel Aviv University and at the

MIT Center for Real Estate's Housing Affordability Initiative. Her many publications on housing policy and politics established her as a leading expert on affordable housing. She has served as a consultant to the Connecticut Blue Ribbon Commission on Affordable Housing and to other state and local housing, planning and zoning boards and commissions.

In 2010, Sharon's outstanding teaching, scholarship and service to Clark University were recognized by her appointment as the Andrea B. and Peter D. Klein '64 Distinguished Professor. She is now an emerita professor of Political Science. Over the years, Sharon has also devoted considerable time to community service in the Worcester area. She has been a member of the Board of Directors of the Central Massachusetts Housing Alliance and chairs the Continuum of Care Board for the City and County of Worcester, which oversees \$6.4 million in HUD grants to organizations that provide housing and services to homeless and formerly homeless families and individuals. She was president of the Solomon Schechter Day School; is a past president of Beth Israel Synagogue; and is currently serving as Vice President of the Jewish Federation of Central Massachusetts.

### Shirley Parker Levine '65

Physician, Researcher, Teacher & Mentor

During her 30-year career as a physician, Shirley Parker Levine '65 also excelled as a researcher and a teacher and mentor to medical students, residents, and fellows, for which she received numerous awards. After graduating from Douglass College, Shirley attended the Woman's Medical College of Pennsylvania, graduating in 1969 as a member of Alpha Omega Alpha. After a medicine internship and residency at the University of Chicago Hospital and Clinics, she completed her residency at the University of California at San Diego, where she then completed a fellowship in Hematology-Oncology, followed by a National Institutes of Health Post-Doctoral Research Fellowship at both the University of California at San Diego and at the San Diego Veterans Administration Hospital.

Shirley joined the Department of Medicine, Division of Hematology, at the University of Texas Health Science Center at San Antonio in 1976, rising up to become a Professor. The work she started during her post-doctoral fellowship continued at the University of Texas Health Science Center and the Audie L. Murphy Memorial Veterans Hospital, where she served as an Attending Physician, Career Development Clinical Investigator, and Medicine Service Assistant Chief in addition to teaching and directing an extracurricular clinical program for Preclinical Medical Students. During her tenure, she was named "Outstanding Faculty," lauded for her presentations and clinical teaching and nominated to the San Antonio Women's Hall of Fame. She also received the Exceptional Teacher Award in 1993, in association with establishing the Shirley P. Levine Annual Award for Clinical Care and Compassion for a Houseofficer.

In 1993, Shirley joined the faculty at the Department of Medicine, Division of Hematology, at Albert Einstein College of Medicine and later served as the Professor and Associate Chairman for Undergraduate Education until her retirement in 2009, when she was appointed an Emeritus Professor of Medicine. During her tenure she served as a trusted career advisor to fourth-year medical students, offering guidance about upcoming medicine residencies. She also supported and advised Fellows completing Hematology and Hematology-Oncology fellowships. Shirley continued to receive accolades for excellence in teaching, including Attending of the Year Award and the Harry H. Gordon Award for Outstanding Clinical Teaching. Concurrent with her work at Albert Einstein College of Medicine, she was the Director of the Clinical Hematology Service at Montefiore Medical Center.

Her research into Platelet Factor 4 and Adult Respiratory Distress Syndrome received funding and support from the Veterans Administration, the National Institutes of Health, and the National Aeronautics and Space Administration. She has presented her research widely and authored several publications and abstracts on Platelet Factor 4, its secretion and impact on coronary artery disease and thrombocytopenic patients. She also authored book chapters in *Wintrobe's Clinical Hematology*. Shirley has served as a visiting professor to other institutions, taught American College of Physicians board review courses and served on the Editorial Board of the *Annals of Internal Medicine*.
