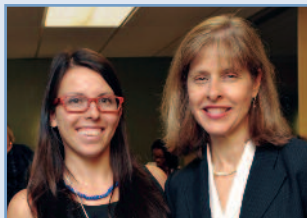
### Volunteering and Participating in AADC Programs

## Leadership Circle

The Mabel Smith Douglass Leadership Circle recognizes the Associate Alumnae of Douglass College's most loyal and committed supporters. ### Elizabeth Rodman Voorhees Society

Gifts of \$25,000+

A founding benefactor of the College, Mrs. Voorhees also bequeathed her estate for the purpose of constructing and endowing a Chapel and left specific instructions that the building include a fireplace and staircase for use in the annual Yule Log ceremony.

### Neilson Family Society

Gifts of \$10,000 - \$24,999

Three generations of the Neilson Family served as benefactors; James Neilson was a notable benefactor and member of the Board of Managers when alma mater was founded. Mr. Neilson donated much of the land on which the Douglass Campus is located.

### Loree Society

Gifts of \$5,000 - \$9,999

Leonor F. Loree, a Rutgers University trustee, funded the construction of an Athletic Field on the Douglass Campus, and was asked to name the field. He called the field "Antilles" in memory of the first American transport to be sunk in World War I.

### Cooper Society

Gifts of \$1,000 - \$4,999

Mr. and Mrs. Drury Cooper owned a home directly across the street from College Hall during alma mater's first year of operation. In 1919, the couple gifted the house to the College and Cooper Hall became the College's second building.

### Jameson Young Alumnae Society

Gifts of \$300 - \$999 (First 10 years post-graduation)

A large part of the land for the Jameson Campus was acquired for the College through the generosity of a member of the Rutgers University Board of Trustees, Edwin C. Jameson. To honor Mr. Jameson's wife, it was named the Mary Gardner Jameson Campus.

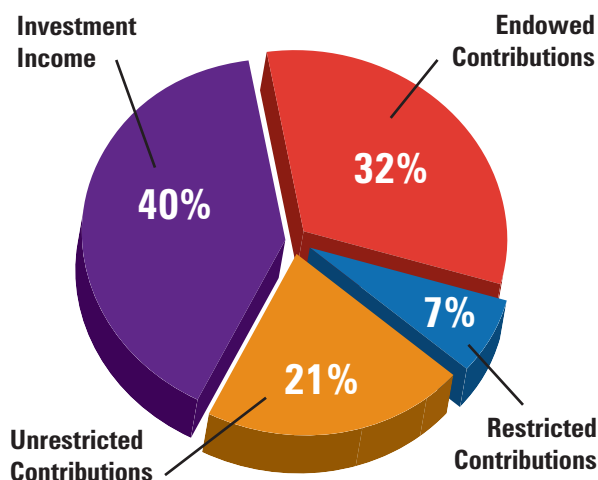
### Important Facts About Fiscal Year 2016 Revenue Received by the AADC and the Douglass Fund

Endowed contributions comprise 32% of all contributions received in FY16. Endowed contributions may be unrestricted or they may be restricted to a certain purpose by the donor. Endowed contributions are invested and maintained in perpetuity. Only the income from these contributions is expendable.

Investment Income is primarily generated by the endowment and 62% of its use is restricted based on donor stipulations.

Non-endowed restricted contributions may be expended, but only for the purpose for which the donor restricted the gift. Restricted gifts represent 7% of FY16 revenue.

The remaining unrestricted contributions represent 21% of all revenue received in FY16. These contributions make it possible for the AADC to develop and promote the connections among Douglass alumnae by providing programs, services, networks and learning opportunities that enrich their lives; and to provide ongoing financial



support to Douglass College and her students through stewardship of the endowed funds of the Associate Alumnae of Douglass College and the Douglass Fund.

Income from other sources, such as GoodShop and AmazonSmile, represents less than 1% of all revenue received in FY16.

**During 2015-16, \$1,133,866 was added to the endowment for the benefit of Douglass and her students.**

**In 2015-16, 50% of the DRC program budget was funded by philanthropic support from the Associate Alumnae of Douglass College and the Douglass Fund.**

\*On April 20, 2015, Rutgers Legal Counsel informed the AADC that it was dissolving the 2005 Memorandum of Agreement that defined AADC's role as the primary fundraiser for Douglass Residential College. In May, 2015, the AADC, the University and the Rutgers University Foundation agreed to enter into a formal mediation process to address these issues. A condition of the mediation process was that neither party could disclose the confidential nature of the discussions. On July 20, 2016, following a series of thoughtful and productive mediation and negotiation sessions and subsequent discussions, Rutgers University and the Rutgers University Foundation (RUF) in partnership with Douglass Residential College (DRC) and the Associate Alumnae of Douglass College, reached an agreement regarding the fundraising structure and alumnae relations program for DRC and the AADC.

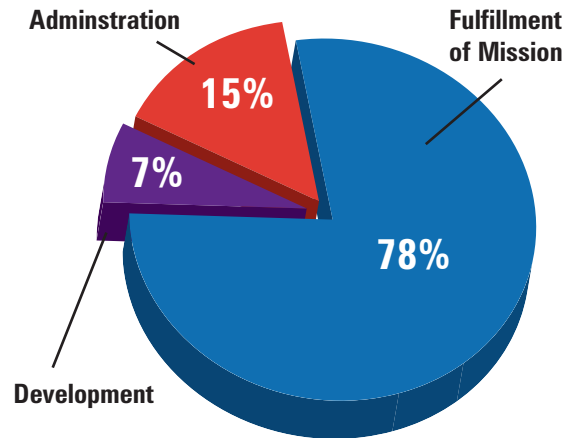
